

# ROYAL RIDGE EQUESTRIAN CENTER HORSE TRAINING/ HORSE CARE AGREEMENT

## **Pricing & Updates**

Training and care package prices are posted on the Serenity Equestrian Center website under the "RREC" page and are subject to change without prior notice. Clients are responsible for reviewing current rates regularly.

# **Training, Lesson & Care Scheduling**

If a client misses a scheduled lesson, the horse will receive a training session in lieu of that lesson. For example, if a horse is in a 3-day-per-week training program, the horse will always receive three total sessions per week (lesson or training), unless weather, illness, or other uncontrollable circumstances prevent it.

## **Cancellation, Make-Ups & Refunds**

RREC maintains a strict no refunds policy—no exceptions. If a training/lesson or care session is canceled due to weather, illness, or other circumstances beyond our control, we will make every reasonable effort to reschedule within the same week. If that is not possible, the session will be made up the following week. Unused sessions do not carry over beyond that point.

# **Payment Terms & Late Fees**

Training and care packages must be paid in full by the 1st of each month. Payments received after the 5th will incur a 10% late fee. Accounts more than 30 days past due may result in suspension of services until payment is received in full. Client agrees to be responsible for any collection costs, including legal fees, incurred by RREC.

# Training, Lesson & Care Schedule

While we make every effort to follow a consistent schedule, specific training/care days cannot be 100% guaranteed due to potential weather delays, illness, or other scheduling conflicts. RREC will always strive to work around the client's schedule when possible. Typical care/training days are Monday through Friday; weekends are generally not scheduled unless there's a scheduling conflict.

#### **Notice of Termination**

A minimum of 30 days written notice is required to discontinue care and/or training services. Client remains financially responsible for the notice period regardless of horse removal date.

#### **Authorized Handlers**

All horses will be primarly trained, handled and cared for by Emily Richards, but may be handled, trained, or cared for by other RREC staff, assistant trainers, grooms, or other qualified personnel.

# Risk Acknowledgment & Liability Release

Client acknowledges that horses are large, powerful, and unpredictable animals that may cause injury, death, or property damage. By signing this agreement, client voluntarily assumes all risks associated with horse training, riding, handling, and related activities. Client agrees that Royal Ridge Equestrian Center, its owners, employees, contractors, and representatives shall not be held liable for any injury, death, illness, or property damage to horse, rider, or spectator, regardless of cause.

# **Veterinary Care & Emergency Authorization**

In the event of illness or injury to the horse, RREC is authorized to obtain veterinary or emergency care at the owner's expense if the owner cannot be reached. RREC will make reasonable efforts to contact the owner prior to obtaining care, but horse welfare will always take priority.

#### Indemnification

Client agrees to indemnify and hold harmless RREC, its owners, employees, contractors, and representatives against any claims, demands, damages, or expenses arising from the horse's behavior, actions, or participation in training activities.

# **Entire Agreement**

This agreement constitutes the full understanding between the parties. Any changes must be made in writing and signed by both parties.
